Chairman Phil Mendelson at the request of the Mayor A PROPOSED RESOLUTION IN THE COUNCIL OF THE DISTRICT OF COLUMBIA Chairman Phil Mendelson, at the request of the Mayor, introduced the following resolution, which was referred to the Committee on To confirm the appointment of Ed Grandis as a member of the Alcoholic Beverage Control Board. RESOLVED, BY COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Alcoholic Beverage Control Board Ed Grandis Confirmation Resolution of 2019". Sec. 2. The Council of the District of Columbia confirms the appointment of: Ed Grandis 1806 Swann Street NW Washington, DC 20009 (Ward 2) as a member of the Alcoholic Beverage Control Board, pursuant to D.C. Official Code § 25-201, to replace Mike Silverstein, for a term to end May 7, 2023. Sec. 3. The Council of the District of Columbia shall transmit a copy of this resolution, upon its adoption, to the nominee and to the Office of the Mayor.

Accomplishments:

- 1. National Capitol Planning Commission (NCPC) 1992 1995: Appointed by the Mayor of the District of Columbia.
- 2. Advisory Neighborhood Commissioner (Washington, DC): Elected through general election to three two-year terms to the Dupont Circle ANC. This publicly elected body advises various DC executive branch agencies on licensing, zoning, public space and land use issues. The ANC is given great weight by these agencies when weighing their decisions. Served as chairman and treasurer during my tenure.
- 3. Ward 2 ANC Redistricting Task Force (Washington, DC): I was asked by the DC Council to serve as chairman to work with the various neighborhoods to revise political boundaries based upon the recent population changes reflected in the census.

Represent clients on administrative matters including hearings regarding resident protests, use of public space and land-use matters including re-zoning and change of use matters. Represent business clients in mediation to resolve complex conflicts with a patron, customer or local neighborhood. I served as a consultant to the District of Columbia to re-design business licensing program, supervise the development of a one-stop licensing center using best practices. Negotiated the MOU between District agencies to coordinate licensing and permitting information. I supervised strategy to centralize information collection from the various agencies to reduce the burden on a business. Used my expert skills to rewrite DC regulations that were in conflict among the agencies as well as remove antiquated regulations and provide for electronic filings and signatures. I supervised and coordinated the effort to reduce paperwork and the time it took for the various processes to be completed.

Seasonal Municipal Judge for the city of Rehoboth Beach, Delaware. In addition to my law practice I served as a seasonal judge handling matters related to the city civil code, traffic code and misdemeanors. This experience added to my training in the relationship of the court with the police department and city agencies. Training on how to execute court rules and problem solve alleged violations of law. This experience was excellent training in learning to listen to each party's recollection of facts, to dissect submitted legal documents, interview witnesses and then the application of law to those facts. I gained valuable experience in how to be impartial; and let the facts take you to the truth of the matter applying the intent of the law not what we would like the law to be. The day to day hearings helped me to learn how to determine the appropriate remedy and fine for a particular violation. Training in how to have the parties see past their anger, biases and egos and work towards a resolution based on the facts and how those facts complied with the working of the law, and if applicable a remedy that reduced the likelihood of recidivism. I developed a methodology to review and organize the dead past conviction files in order to determine how to collect on the long standing unpaid fines for violations. I then implemented a program coordinating with the police department to track down and locate past convicted violators nationwide. Through this program I issued warrants notifying the relevant state police departments to apprehend such violators. This program significantly reduced the size of the "dead" files resulting in the collection of these fines for the city and the clearing up of the violator's record.

In addition to my full-time law practice I served as a patrol officer, bike officer, and assistant detective during my tours. Received certified training under the Delaware State Police guidelines. This training and experience helped me to understand the role of community policing and how to more effectively work with concerned residents on resolving citizen complaints. Through my service in the investigative unit and attendance in state police certified training classes to investigate crimes I was trained to develop methods for problem solving. Also, served on committees with the local elected officials regarding public policy issues and reviewing legislation to improve policing and reduce crime. Made arrest and investigated both misdemeanor and felony violations.

American Forum

Co-Founder and First Executive Director

I initially established the Virginia Forum in Richmond, Virginia with other community organizers. A print journalist and I were the co-founders and co-creators of the 501(c) (3) public policy communications organization. The mission of the Forum is to influence public policy through the development of Op-Ed articles addressing topical social and economic policies in Virginia. The print and electronic media was immediately responsive in using the articles on their editorial pages. We developed PSA and other media products for the electronic media. After about four years under my leadership we established a national board creating the American Forum with Virginia serving as the model for other state forums. Each state program has its own independent editorial board composed of community organizers in their state. The national office coordinates with the volunteers in the state forums. The state forum develops its own policy piece each month. The national office is responsible for the copy editing and distribution of each month's editorial product in each state that has a Forum organization. There are currently 23 active forums with six forums in development nationwide.

Environmental Policy Institute

Executive Director Citizens Mining Project

To best understand my work in this position, please review my job at the Environmental Policy Center (EPC) first. This job flowed from my successful leadership in that position.

At EPI I had two primary responsibilities:

- 1. Supervise national public participation with OSM regarding the development of the interim federal program, as well as
- 2. Supervise and coordinate with individuals and organizations throughout the coal regions to develop testimony, expert memorandums on complex policy issues for the development of the permanent state and federal programs.

I traveled to many of the coalfield states training local residents, farmers, ranchers, and Native Americans on how to participate in the federal and state rule making process. I skillfully spoke publicly to these groups. I would review their recommendations and help them edit and organize their high-quality documents and publications supporting policy consistent with the requirements of a particular state rule making. These documents designed for a particular state program addressed its own unique environmental and agricultural circumstances as well as markedly different types of surface mining and surface impacts of underground mining. This was not a cookie-cutter approach but rather using the theme of the federal program we offered policy guidance for each state program to be consistent with the federal program. Our recommendations addressed the complex issues including location and size of the mine, ownership, terrain, hydrology, soil, the type/depth of the coal seams and various mining methodologies. I supervised

and trained individuals who testify at either the OSM or state hearings on a particular state program.

It was important to work with coal industry representatives and seek common ground. Even within the coal industry there are significant differences in their corporate views. International coal companies have a much different corporate view than do small independent coal mine operators. The multi-state mining company has a corporate view different from either of them. My leadership skills included my ability to reach out, negotiate and seek compromise if it did not weaken federal mandates. I met with state officials in the interpretation of policies, regulations and laws related to surface coal mining and worked with the local citizen leadership to meet with their state agencies in developing, language that would be consistent with the federal program requirements.

Environmental Policy Center Washington, DC

Policy Analyst

Six years overseeing coal mining policy development with Congress and coal producing state legislatures. I drafted and supervised development of technical and complex written documents and correspondence regarding surface coal mining activities that disturbed land, water and air resources in the various coal regions throughout the nation. This scientific, factual and statistical documentation was provided to Congress and state legislatures to assist in the development of the 1977 Federal Surface Mining Control and Reclamation Act (SMCRA) as well as the development of state statutes.

I drafted extensive expert testimony for amendments to SMCRA and skillfully supervised private citizens in support of the adoption of the 1977 statute in meetings with congressional staff and in their preparation to testify at congressional hearings. We worked closely with and provided training to individual residents, farmers, ranchers, Native American tribes, scientist, as well as local and national environmental, conservation and agricultural organizations to assist their participation in this process.

I skillfully met with federal officials from DOI, MMS, Corp of Engineers, MHSA, EPA, and CEQ as well as with members of Congress and their staffs, and state agency officials in discussions of complex policies, regulations, laws related to the surface coal mining.

In working with the development of SMCRA I became familiar with other federal statutes including the Endangered Species Act, Clean Water Act, National Environmental Policy Act, National Historic Preservation Act, and Clean Air Act. I also provided leadership and supervision in developing technical regulations for these statutes to be consistent with SMCRA. We worked closely with other organizations that took the lead in overseeing the other federal statutes to advise them on how SMCRA needed to be addressed.

I would travel extensively to many of the states that had active surface mining operations to study and document the current reclamation practices gathering scientific data. During these travels, I would meet with local residents, farmers, ranchers, and Native Americans and help them organize their findings. I would also set up or attend meetings with local state, county and town officials in developing statutory language to meet the requirements of SMCRA or to be an expert witness to a state or local hearing on mining practices. My work required me to conduct technical, controversial and sensitive briefings with state officials or coal industry representatives in the development of complex policies, regulations and laws related to surface coal mining regulatory programs.

Virginia Citizens for Better Reclamation

Wise, VA Executive Director

Community organizer and policy analyst for citizen's organization before the adoption of the 1977 Federal Surface Mining Control and Reclamation Act. My duties were similar to the responsibilities outlined under EPI directed at the state level in Virginia.

I was effective in obtaining state wide media focus on the damage that the surface coal operations caused due to inadequate state mining reclamation laws.

I provided skillful supervision in obtaining new state statutory protections through the Virginia General Assembly prior to the federal law. We documented mining related damages and coordinated with other citizen and environmental organizations to provide assistance to EPC. Traveled the state to testify before the Virginia General Assembly and meet with other organizations supporting our work.
