## A BILL

To require a review of sanctions with respect to Russian kleptocrats and human rights abusers.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Corruption, Over-  
5 throwing Rule of Law, and Ruining Ukraine: Putin’s  
6 Trifecta Act” or “CORRUPT Act”.

1 **SEC. 2. REVIEW OF SANCTIONS WITH RESPECT TO RUSSIAN**  
2 **KLEPTOCRATS AND HUMAN RIGHTS ABUS-**  
3 **ERS.**

4 (a) DETERMINATION WITH RESPECT TO IMPOSITION  
5 OF SANCTIONS.—Not later than 30 days after the date  
6 of the enactment of this Act, the President shall submit  
7 to the appropriate congressional committees a determina-  
8 tion, including a detailed justification, of whether any per-  
9 son listed in subsection (b) meets the criteria for the impo-  
10 sition of sanctions under provisions of law that authorize  
11 the imposition of sanctions relating to corruption or  
12 human rights violations.

1           (c) APPROPRIATE CONGRESSIONAL COMMITTEES DE-  
2 FINED.—In this section, the term “appropriate congres-  
3 sional committees” means—

4           (1) the Committee on Foreign Affairs and the  
5           Committee on Financial Services of the House of  
6           Representatives; and

7           (2) the Committee on Foreign Relations and  
8           the Committee on Banking, Housing, and Urban Af-  
9           fairs of the Senate.
