BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$25,000 from the Alabama State Board of Midwifery Fund to the Alabama State Board of Midwifery for the fiscal year ending September 30, 2020.

Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$70,000 from the Genetic Counseling Fund to the Alabama Board of Genetic Counseling for the fiscal year ending September 30, 2020.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$61,620 from the Alabama Bail Bond Board Fund to the Alabama Professional Bail Bonding Board for the fiscal year ending September 30, 2020.

Section 4. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$3,050,000 from the Forever Wild Land Trust Fund to the Board

of Forever Wild Land Trust for the fiscal year ending
September 30, 2020.

Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$11,000,000 from the State General Fund to the Department of Finance for implementation costs for replacement of the state's human resource management and payroll system for the fiscal year ending September 30, 2020.

Section 6. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$600,000 from the State General Fund to the Department of Conservation and Natural Resources for the fiscal year ending September 30, 2020 for the purpose of repairs at Chattahoochee and Joe Wheeler State Parks. Of the above appropriation, \$300,000 shall be expended for Chattahoochee and \$300,000 shall be expended for Joe Wheeler.

Section 7. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$400,000 from the State General Fund to the Legislature for the fiscal year ending September 30, 2020 to be used for renovations to the House Chamber.

Section 8. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$525,000 from the State General Fund to the Alabama Forestry Commission for the fiscal year ending September 30, 2020 of which \$325,000 shall be used for repairs at Flagg Mountain and

Claude D. Kelley State Park; and \$200,000 shall be used for the Forest Workforce Training Institute.

Section 9. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$1,500,000 from the State General Fund to the Department of Mental Health for the Rural County Crisis Diversion Project for Southwest Mental Health, Catawba Mental Health, and Demopolis Mental Health.

Section 10. In addition to all other appropriations heretofore of hereafter made, there is hereby appropriated \$100,000 from the State General Fund to the Department of Human Resources for the fiscal year ending September 30, 2020, to be used for the Mary Hill Family Resource Center.

Section 11. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$5,000,000 from the State General Fund to the General Fund Budget Reserve Fund for the fiscal year ending September 30, 2020, to be used for initial funding for the General Fund Budget Reserve Fund created in HB\_\_\_ or SB\_\_\_ of the 2020 Regular Session.

Section 12. This act shall become effective immediately upon its passage and approval by the Governor, or upon its otherwise becoming law.
