3 SECTION 1. CONDITIONS OF ACQUIRING CITIZENSHIP FOR

4 NONCITIZEN NATIONALS OF THE UNITED
5 STATES WHO ARE CHILDREN OF UNITED
6 STATES CITIZENS.

7 Section 320(a) of the Immigration and Nationality
8 Act (8 U.S.C. 1431) is amended—

(1) in the matter preceding paragraph (1), by
 inserting after "outside of the United States" the
 following: ", or born in an outlying possession of the
 United States,"; and

5 (2) in paragraph (3), by inserting before the pe-6 riod at the end the following: ", except that the re-7 quirement under this paragraph to be admitted to 8 the United States as a lawful permanent resident 9 shall not apply in the case of a child born in an out-10 lying possession of the United States".
