- 1 Recognizing and commending Prayer in Action Ministries International on the occasion of
- 2 its 30th anniversary; and for other purposes.
- 3 WHEREAS, Prayer in Action Ministries International is an intercessory prayer ministry with
- 4 a missionary vision for the nations of the world; and
- 5 WHEREAS, born on December 10, 1937, in Macon, Georgia, to her parents, Willie and
- 6 Alberta Stubbs, Viola S. Walker is an Apostle of Prayer and the founder and President of
- 7 Prayer in Action Ministries International; and
- 8 WHEREAS, Prayer in Action Ministries International began in April, 1987, as a Saturday
- 9 morning prayer breakfast in the home of Apostle Viola S. Walker with ten people attending,
- and the prayer focus was according to Psalm 32:8 which says "I will instruct thee and teach
- 11 thee in the way which thou shalt go: I will guide thee with mine eye"; and
- 12 WHEREAS, April, 1990, was the third anniversary victory celebration of Prayer in Action
- 13 Ministries International; from that time forward, an annual celebration has been held in the
- 14 name of the Lord, and in December, 1992, the ministry moved into an office park building,
- where the ministry started holding schools of prayer and was a great pouring out of God's

- 17 WHEREAS, in early 1995, the members of Prayer in Action Ministries International began
- 18 to travel throughout the State of Georgia with the ministry of intercessory prayer and the
- 19 theme of "Taking Georgia for Jesus"; and
- 20 WHEREAS, out of the "Taking Georgia for Jesus" mission were born several branches of
- 21 Prayer in Action Ministries International, and the ministry began to grow and expand further,

- 25 Call to Prayer" to all 50 states, and currently, 30 prayer watches weekly and 4 teaching

- 27 WHEREAS, it is abundantly fitting and proper that this remarkable ministry's innumerable
- 28 good works rendered on behalf of persons in need be appropriately recognized.

- 30 recognize the rich history of Prayer in Action Ministries International, commend its 30 years
- 31 of dedicated service to the Lord and community, and extend their warmest best wishes for
