SYNOPSIS:           This bill makes a supplemental appropriation from the Alabama State Board of Midwifery Fund to the Alabama State Board of Midwifery in the amount of \$25,000 for the fiscal year ending September 30, 2020; makes a supplemental appropriation from the Genetic Counseling Fund to the Alabama Board of Genetic Counseling in the amount of \$70,000 for the fiscal year ending September 30, 2020; makes a supplemental appropriation from the Alabama Bail Bond Board Fund to the Alabama Professional Bail Bonding Board in the amount of \$61,620 for the fiscal year ending September 30, 2020; makes a supplemental appropriation from the Forever Wild Land Trust Fund to the Board of Forever Wild Land Trust in the amount of \$3,050,000 for the fiscal year ending September 30, 2020; makes a supplemental appropriation from the State General Fund to the Department of Finance in the amount of \$11,000,000 for the fiscal year ending September 30, 2020; makes a supplemental appropriation from

1 the State General Fund to the Department of  
2 Conservation and Natural Resources in the amount of  
3 \$600,000 for the fiscal year ending September 30,  
4 2020; makes a supplemental appropriation from the  
5 State General Fund to the Legislature in the amount

1           To make a supplemental appropriation from the  
2   Alabama State Board of Midwifery Fund to the Alabama State  
3   Board of Midwifery in the amount of \$25,000 for the fiscal  
4   year ending September 30, 2020; to make a supplemental  
5   appropriation from the Genetic Counseling Fund to the Alabama  
6   Board of Genetic Counseling in the amount of \$70,000 for the  
7   fiscal year ending September 30, 2020; to make a supplemental  
8   appropriation from the Alabama Bail Bond Board Fund to the  
9   Alabama Professional Bail Bonding Board in the amount of  
10   \$61,620 for the fiscal year ending September 30, 2020; to make  
11   a supplemental appropriation from the Forever Wild Land Trust  
12   Fund to the Board of Forever Wild Land Trust in the amount of  
13   \$3,050,000 for the fiscal year ending September 30, 2020; to  
14   make a supplemental appropriation from the State General Fund  
15   to the Department of Finance in the amount of \$11,000,000 for  
16   the fiscal year ending September 30, 2020; to make a  
17   supplemental appropriation from the State General Fund to the  
18   Department of Conservation and Natural Resources in the amount  
19   of \$600,000 for the fiscal year ending September 30, 2020; to  
20   make a supplemental appropriation from the State General Fund  
21   to the Legislature in the amount of \$400,000 for the fiscal  
22   year ending September 30, 2020; to make a supplemental  
23   appropriation from the State General Fund to the Alabama  
24   Forestry Commission in the amount of \$525,000 for the fiscal  
25   year ending September 30, 2020; to make a supplemental  
26   appropriation from the State General Fund to the Department of  
27   Mental Health in the amount of \$1,500,000 for the fiscal year

1 ending September 30, 2020; to make a supplemental  
2 appropriation from the State General Fund to the Department of  
3 Human Resources in the amount of \$100,000 for the fiscal year  
4 ending September 30, 2020; and to make a supplemental  
5 appropriation from the State General Fund to the General Fund  
6 Budget Reserve Fund in the amount of \$5,000,000 for the fiscal  
7 year ending September 30, 2020.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9           Section 1. In addition to all other appropriations  
10 heretofore or hereafter made, there is hereby appropriated  
11 \$25,000 from the Alabama State Board of Midwifery Fund to the  
12 Alabama State Board of Midwifery for the fiscal year ending  
13 September 30, 2020.

14           Section 2. In addition to all other appropriations  
15 heretofore or hereafter made, there is hereby appropriated  
16 \$70,000 from the Genetic Counseling Fund to the Alabama Board  
17 of Genetic Counseling for the fiscal year ending September 30,  
18 2020.

19           Section 3. In addition to all other appropriations  
20 heretofore or hereafter made, there is hereby appropriated  
21 \$61,620 from the Alabama Bail Bond Board Fund to the Alabama  
22 Professional Bail Bonding Board for the fiscal year ending  
23 September 30, 2020.

24           Section 4. In addition to all other appropriations  
25 heretofore and hereafter made, there is hereby appropriated  
26 \$3,050,000 from the Forever Wild Land Trust Fund to the Board

1 of Forever Wild Land Trust for the fiscal year ending  
2 September 30, 2020.

3 Section 5. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$11,000,000 from the State General Fund to the Department of  
6 Finance for implementation costs for replacement of the  
7 state's human resource management and payroll system for the  
8 fiscal year ending September 30, 2020.

9 Section 6. In addition to all other appropriations  
10 heretofore or hereafter made, there is hereby appropriated  
11 \$600,000 from the State General Fund to the Department of  
12 Conservation and Natural Resources for the fiscal year ending  
13 September 30, 2020 for the purpose of repairs at Chattahoochee  
14 and Joe Wheeler State Parks. Of the above appropriation,  
15 \$300,000 shall be expended for Chattahoochee and \$300,000  
16 shall be expended for Joe Wheeler.

17 Section 7. In addition to all other appropriations  
18 heretofore and hereafter made, there is hereby appropriated  
19 \$400,000 from the State General Fund to the Legislature for  
20 the fiscal year ending September 30, 2020 to be used for  
21 renovations to the House Chamber.

22 Section 8. In addition to all other appropriations  
23 heretofore and hereafter made, there is hereby appropriated  
24 \$525,000 from the State General Fund to the Alabama Forestry  
25 Commission for the fiscal year ending September 30, 2020 of  
26 which \$325,000 shall be used for repairs at Flag Mountain and

1 Claude D. Kelley State Park; and \$200,000 shall be used for  
2 the Forest Workforce Training Institute.

3 Section 9. In addition to all other appropriations  
4 heretofore and hereafter made, there is hereby appropriated  
5 \$1,500,000 from the State General Fund to the Department of  
6 Mental Health for the Rural County Crisis Diversion Project  
7 for Southwest Mental Health, Catawba Mental Health, and  
8 Demopolis Mental Health.

9 Section 10. In addition to all other appropriations  
10 heretofore of hereafter made, there is hereby appropriated  
11 \$100,000 from the State General Fund to the Department of  
12 Human Resources for the fiscal year ending September 30, 2020,  
13 to be used for the Mary Hill Family Resource Center.

14 Section 11. In addition to all other appropriations  
15 heretofore and hereafter made, there is hereby appropriated  
16 \$5,000,000 from the State General Fund to the General Fund  
17 Budget Reserve Fund for the fiscal year ending September 30,  
18 2020, to be used for initial funding for the General Fund  
19 Budget Reserve Fund created in HB\_\_\_ or SB\_\_\_ of the 2020  
20 Regular Session.

21 Section 12. This act shall become effective  
22 immediately upon its passage and approval by the Governor, or  
23 upon its otherwise becoming law.
