PURPOSE AND FUNCTIONS

- 2. The signatories to the WMATA Compact hereby adopt this

- 4. There is hereby created the Washington Metrorail Safety
 Commission, an instrumentality of each signatory, which shall be a

 19 INVESTIGATIONS, EXAMINATIONS, AND TESTING OF THE PROPERTY, EQUIPMENT,
 20 FACILITIES, ROLLING STOCK, AND OPERATIONS OF THE WMATA RAIL SYSTEM,
 21 INCLUDING ELECTRONIC INFORMATION AND DATABASES:
