# **A BILL**

To amend the Federal Water Pollution Control Act to  
reauthorize the Chesapeake Bay Program.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Chesapeake Bay Pro-  
5 gram Reauthorization Act”.

6 **SEC. 2. REAUTHORIZATION OF CHESAPEAKE BAY PRO-**  
7 **GRAM.**

8        Section 117(j) of the Federal Water Pollution Control  
9 Act (33 U.S.C. 1267(j)) is amended by striking  
10 “\$40,000,000 for each of fiscal years 2001 through 2005”  
11 and inserting “\$90,000,000 for fiscal year 2020,  
12 \$90,500,000 for fiscal year 2021, \$91,000,000 for fiscal  
13 year 2022, \$91,500,000 for fiscal year 2023, and  
14 \$92,000,000 for fiscal year 2024”.
