## A BILL

| 4  | This Act may be cited as the "Farm to Food Bank              |
| 5  | Enhancement Act of 2020".                                    |
| 6  | SEC. 2. ENHANCED PROJECTS TO HARVEST, PROCESS,               |
| 7  | PACKAGE, OR TRANSPORT DONATED COM-                           |
| 8  | MODITIES.  |
| 9  | (a) Definitions.—In this section:                            |
| 10 | (1) COVID-19.—The term "COVID-19"                            |
| 11 | means the 2019 Novel Coronavirus or 2019–nCoV.               |
| 12 | (2) Emergency feeding organization.—                         |
| 13 | The term "emergency feeding organization" has the            |
| 14 | meaning given the term in section 201A of the                |
| 15 | Emergency Food Assistance Act of 1983 (7 U.S.C.              |
| 16 | 7501).   |
| 17 | (3) Project.—The term "project" has the                      |
| 18 | meaning given the term in section 203D(d)(1) of the          |
| 19 | Emergency Food Assistance Act of 1983 (7 U.S.C.              |
| 20 | 7507(d)(1)).   |
| 21 | (4) Priority agricultural product.—The                       |
| 22 | term "priority agricultural product" means a dairy,          |
| 23 | meat, or poultry product, or a specialty crop—               |
| 24 | (A) packaged or marketed for sale to com-                    |
| 25 | mercial or food service industries                           |

| 10 | gency Food Assistance Act of 1983 (7 U.S.C. 7507).   |
| 11 | (7) STATE AGENCY.—The term "State agency"            |
| 12 | has the meaning given the term in section 203D of    |

| 15 | (b) Enhanced Projects.—                              |
| 16 | (1) In general.—Subject to paragraphs (3)            |
| 17 | and (4), using funds made available under sub-       |
| 18 | section (d), the Secretary may provide funds to      |
| 19 | States to pay for harvesting, processing, packaging, |
| 20 | or transportation costs of carrying out a project.   |
| 21 | (2) Guidance.—Not later than 30 days after           |
| 22 | the date of enactment of this Act, the Secretary     |
| 23 | shall issue guidance to States—                      |
| 24 | (A) to carry out this section;                       |

| 8  | (A) ELIGIBILITY FOR ALLOCATION.—The              |
| 9  | Secretary shall allocate funds made available    |
| 10 | under subsection (d) based on the formula in     |
| 11 | effect under section 214(a) of the Emergency     |
| 12 | Food Assistance Act of 1983 (7 U.S.C.            |
| 13 | 7515(a)), among States that timely submit a      |
| 14 | State plan of operation for a project that in-   |
| 15 | cludes—  |
| 16 | (i) a list of emergency feeding organi-          |
| 17 | zations in the State that will operate the       |
| 18 | project in partnership with the State agen-      |
| 19 | ey;  |
| 20 | (ii) at the option of the State, a list          |
| 21 | of priority agricultural products located in     |
| 22 | the State that are for donation to emer-         |
| 23 | gency feeding organizations and ready for        |

| 8  | (B) REALLOCATION.—If the Secretary de-            |
| 9  | termines that a State will not expend all the     |
| 10 | funds allocated to the State under subpara-       |
| 11 | graph (A), the Secretary shall reallocate the un- |
| 12 | expended funds to other eligible States.          |
| 13 | (C) Report.—Each State that receives              |
| 14 | funds allocated under this paragraph shall sub-   |
| 15 | mit to the Secretary financial reports on a reg-  |
| 16 | ular basis describing the use of the funds.       |
| 17 | (4) Use of funds.—                                |
| 18 | (A) IN GENERAL.—A State that receives             |
| 19 | funds under section 203D(d)(5) of the Emer-       |
| 20 | gency Food Assistance Act of 1983 (7 U.S.C.       |

| 17 | this section may enter into cooperative agreements |
| 18 | with State agencies of other States under section  |
| 19 | 203B(d) of the Emergency Food Assistance Act of    |
| 20 | 1983 (7 U.S.C. 7507(d)) to maximize the use of     |
| 21 | commodities donated under the project.             |
| 22 | (2) Submission.—Not later than 15 days after       |
| 23 | entering into a cooperative agreement under sub-   |
| 24 | paragraph (A), a State agency shall submit such    |
