## A BILL ENTITLED

1 AN ACT concerning

### 2 Election Law – Polling Places at Continuing Care Retirement Communities

3 FOR the purpose of requiring local boards of elections to establish separate precincts at certain continuing care retirement communities under certain circumstances to 4  $\mathbf{5}$ specifically serve the retirement communities; requiring continuing care retirement 6 community providers to provide certain facilities and services to the local board if a 7 polling place is established at the continuing care retirement community; defining a 8 certain term; providing for a delayed effective date; and generally relating to the 9 establishment of precincts and polling places at continuing care retirement communities. 10

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
  That the Laws of Maryland read as follows:

### 20 (a) (1) Subject to [paragraph] **PARAGRAPHS** (2) **AND** (3) of this subsection, as 21 it deems it expedient for the convenience of voters, a local board may:

$8\\9\\10$	(ii) If, in accordance with subparagraph (i) of this paragraph, a polling place is established at an institution of higher education that receives State funds, that institution shall:

20 21 22 23 24	(3) (I) IN THIS PARAGRAPH, "CONTINUING CARE RETIREMENT COMMUNITY" MEANS A FACILITY IN WHICH A PROVIDER THAT HOLDS A CERTIFICATE OF REGISTRATION UNDER § 10–412 OR § 10–413 OF THE HUMAN SERVICES ARTICLE PROVIDES CARE TO AT LEAST 200 INDIVIDUALS WHO ARE AT LEAST 60 YEARS OLD AND NOT RELATED BY BLOOD OR MARRIAGE TO THE PROVIDER.

2. PROVIDE ASSISTANCE TO THE LOCAL BOARD IN
 RECRUITING ELECTION JUDGES FROM AMONG THE RESIDENTS OF THE CONTINUING
 CARE RETIREMENT COMMUNITY TO STAFF THE POLLING PLACE.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 January 1, 2021.
