15 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$25,000 from the Alabama State Board of Midwifery Fund to the Alabama State Board of Midwifery for the fiscal year ending September 30, 2020.

21 Section 2. In addition to all other appropriations 22 heretofore or hereafter made, there is hereby appropriated 23 \$70,000 from the Genetic Counseling Fund to the Alabama Board 24 of Genetic Counseling for the fiscal year ending September 30, 25 2020. Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$61,620 from the Alabama Bail Bond Board Fund to the Alabama Professional Bail Bonding Board for the fiscal year ending September 30, 2020.

6 Section 4. In addition to all other appropriations 7 heretofore and hereafter made, there is hereby appropriated 8 \$3,050,000 from the Forever Wild Land Trust Fund to the Board 9 of Forever Wild Land Trust for the fiscal year ending 10 September 30, 2020.

Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$11,000,000 from the State General Fund to the Department of Finance for implementation costs for replacement of the state's human resource management and payroll system for the fiscal year ending September 30, 2020.

17 Section 6. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated 18 \$600,000 from the State General Fund to the Department of 19 Conservation and Natural Resources for the fiscal year ending 20 21 September 30, 2020 for the purpose of repairs at Chattahoochee 22 and Joe Wheeler State Parks. Of the above appropriation, \$300,000 shall be expended for Chattahoochee and \$300,000 23 24 shall be expended for Joe Wheeler.

Section 7. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$400,000 from the State General Fund to the Legislature for the fiscal year ending September 30, 2020 to be used for renovations to the House Chamber.

6 Section 8. In addition to all other appropriations 7 heretofore and hereafter made, there is hereby appropriated 8 \$525,000 from the State General Fund to the Alabama Forestry 9 Commission for the fiscal year ending September 30, 2020 of 10 which \$325,000 shall be used for repairs at Flagg Mountain and 11 Claude D. Kelley State Park; and \$200,000 shall be used for 12 the Forest Workforce Training Institute.

13 Section 9. In addition to all other appropriations 14 heretofore and hereafter made, there is hereby appropriated 15 \$2,500,000 from the State General Fund to the Department of 16 Mental Health for the Rural County Crisis Diversion Project 17 for Southwest Mental Health, Cahaba Mental Health, Demopolis 18 Mental Health, Wellstone Mental Health Authority, and 19 Northwest Mental Health Center.

20 Section 10. In addition to all other appropriations 21 heretofore of hereafter made, there is hereby appropriated 22 \$100,000 from the State General Fund to the Department of 23 Human Resources for the fiscal year ending September 30, 2020, 24 to be used for the Mary Hill Family Resource Center.

Section 11. In addition to all other appropriations heretofore and hereafter made, there is hereby appropriated \$5,000,000 from the State General Fund to the Department of Public Health for the fiscal year ending September 30, 2020 to be used for Coronavirus preparedness and response activities.

6 Section 12. In addition to all other appropriations 7 heretofore and hereafter made, there is hereby appropriated 8 \$5,000,000 from the State General Fund to the General Fund 9 Budget Reserve Fund for the fiscal year ending September 30, 10 2020, to be used for initial funding for the General Fund 11 Budget Reserve Fund created in SB129 of the 2020 Regular 12 Session.

Section 13. This act shall become effective immediately upon its passage and approval by the Governor, or upon its otherwise becoming law.
