# **A BILL**

To amend the Federal Water Pollution Control Act to establish a grant program to support the restoration of San Francisco Bay.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “San Francisco Bay Res-*  
 5       *toration Act”.*

6       **SEC. 2. SAN FRANCISCO BAY RESTORATION GRANT PRO-**  
 7               **GRAM.**

8       *Title I of the Federal Water Pollution Control Act (33*  
 9       *U.S.C. 1251 et seq.) is amended by adding at the end the*  
 10       *following:*

11       **“SEC. 124. SAN FRANCISCO BAY RESTORATION GRANT PRO-**  
 12               **GRAM.**

13       “(a) *DEFINITIONS.—In this section:*

14               “(1) *ESTUARY PARTNERSHIP.—The term ‘Estu-*  
 15               *ary Partnership’ means the San Francisco Estuary*  
 16               *Partnership, designated as the management con-*  
 17               *ference for the San Francisco Bay under section 320.*

18               “(2) *SAN FRANCISCO BAY PLAN.—The term ‘San*  
 19               *Francisco Bay Plan’ means—*

20                       “(A) *until the date of the completion of the*  
 21                       *plan developed by the Director under subsection*  
 22                       *(d), the comprehensive conservation and manage-*  
 23                       *ment plan approved under section 320 for the*  
 24                       *San Francisco Bay estuary; and*

1           “(B) on and after the date of the completion  
2           of the plan developed by the Director under sub-  
3           section (d), the plan developed by the Director  
4           under subsection (d).

5           “(b) *PROGRAM OFFICE.*—

6           “(1) *ESTABLISHMENT.*—The Administrator shall  
7           establish in the Environmental Protection Agency a  
8           San Francisco Bay Program Office. The Office shall  
9           be located at the headquarters of Region 9 of the En-  
10          vironmental Protection Agency.

11          “(2) *APPOINTMENT OF DIRECTOR.*—The Admin-  
12          istrator shall appoint a Director of the Office, who  
13          shall have management experience and technical ex-  
14          pertise relating to the San Francisco Bay and be  
15          highly qualified to direct the development and imple-  
16          mentation of projects, activities, and studies necessary  
17          to implement the San Francisco Bay Plan.

18          “(3) *DELEGATION OF AUTHORITY; STAFFING.*—  
19          The Administrator shall delegate to the Director such  
20          authority and provide such staff as may be necessary  
21          to carry out this section.

22          “(c) *ANNUAL PRIORITY LIST.*—

23          “(1) *IN GENERAL.*—After providing public no-  
24          tice, the Director shall annually compile a priority  
25          list, consistent with the San Francisco Bay Plan,

1     *identifying and prioritizing the projects, activities,*  
2     *and studies to be carried out with amounts made*  
3     *available under subsection (e).*

4             “(2) *INCLUSIONS.—The annual priority list*  
5     *compiled under paragraph (1) shall include the fol-*  
6     *lowing:*

7                     “(A) *Projects, activities, and studies, in-*  
8     *cluding restoration projects and habitat improve-*  
9     *ment for fish, waterfowl, and wildlife, that ad-*  
10    *vance the goals and objectives of the San Fran-*  
11    *cisco Bay Plan, for—*

12                             “(i) *water quality improvement, in-*  
13     *cluding the reduction of marine litter;*

14                             “(ii) *wetland, riverine, and estuary*  
15     *restoration and protection;*

16                             “(iii) *nearshore and endangered species*  
17     *recovery; and*

18                             “(iv) *adaptation to climate change.*

19                     “(B) *Information on the projects, activities,*  
20     *and studies specified under subparagraph (A),*  
21     *including—*

22                             “(i) *the identity of each entity receiv-*  
23     *ing assistance pursuant to subsection (e);*  
24     *and*

1                   “(ii) a description of the communities  
2                   to be served.

3                   “(C) The criteria and methods established  
4                   by the Director for identification of projects, ac-  
5                   tivities, and studies to be included on the annual  
6                   priority list.

7                   “(3) CONSULTATION.—In compiling the annual  
8                   priority list under paragraph (1), the Director shall  
9                   consult with, and consider the recommendations of—

10                  “(A) the Estuary Partnership;

11                  “(B) the State of California and affected  
12                  local governments in the San Francisco Bay es-  
13                  tuary watershed;

14                  “(C) the San Francisco Bay Restoration  
15                  Authority; and

16                  “(D) any other relevant stakeholder involved  
17                  with the protection and restoration of the San  
18                  Francisco Bay estuary that the Director deter-  
19                  mines to be appropriate.

20                  “(d) SAN FRANCISCO BAY PLAN.—

21                  “(1) IN GENERAL.—Not later than 5 years after  
22                  the date of enactment of this section, the Director, in  
23                  conjunction with the Estuary Partnership, shall re-  
24                  view and revise the comprehensive conservation and  
25                  management plan approved under section 320 for the

1     *San Francisco Bay estuary to develop a plan to guide*  
2     *the projects, activities, and studies of the Office to ad-*  
3     *dress the restoration and protection of the San Fran-*  
4     *cisco Bay.*

5             “(2) *REVISION OF SAN FRANCISCO BAY PLAN.*—  
6     *Not less often than once every 5 years after the date*  
7     *of the completion of the plan described in paragraph*  
8     *(1), the Director shall review, and revise as appro-*  
9     *priate, the San Francisco Bay Plan.*

10            “(3) *OUTREACH.*—*In carrying out this sub-*  
11     *section, the Director shall consult with the Estuary*  
12     *Partnership and Indian tribes and solicit input from*  
13     *other non-Federal stakeholders.*

14            “(e) *GRANT PROGRAM.*—

15            “(1) *IN GENERAL.*—*The Director may provide*  
16     *funding through cooperative agreements, grants, or*  
17     *other means to State and local agencies, special dis-*  
18     *tricts, and public or nonprofit agencies, institutions,*  
19     *and organizations, including the Estuary Partner-*  
20     *ship, for projects, activities, and studies identified on*  
21     *the annual priority list compiled under subsection*  
22     *(c).*

23            “(2) *MAXIMUM AMOUNT OF GRANTS; NON-FED-*  
24     *ERAL SHARE.*—

1           “(A) *MAXIMUM AMOUNT OF GRANTS.*—  
2           *Amounts provided to any entity under this sec-*  
3           *tion for a fiscal year shall not exceed an amount*  
4           *equal to 75 percent of the total cost of any*  
5           *projects, activities, and studies that are to be*  
6           *carried out using those amounts.*

7           “(B) *NON-FEDERAL SHARE.*—*Not less than*  
8           *25 percent of the cost of any project, activity, or*  
9           *study carried out using amounts provided under*  
10          *this section shall be provided from non-Federal*  
11          *sources.*

12          “(f) *FUNDING.*—

13               “(1) *AUTHORIZATION OF APPROPRIATIONS.*—  
14               *There is authorized to be appropriated to carry out*  
15               *this section \$25,000,000 for each of fiscal years 2020*  
16               *through 2024.*

17               “(2) *ADMINISTRATIVE EXPENSES.*—*Of the*  
18               *amount made available to carry out this section for*  
19               *a fiscal year, the Director may not use more than 5*  
20               *percent to pay administrative expenses incurred in*  
21               *carrying out this section.*

22               “(3) *PROHIBITION.*—*No amounts made available*  
23               *under this section may be used for the administration*  
24               *of a management conference under section 320.*



1       “(g) *ANNUAL BUDGET PLAN.*—*The President, as part*  
2 *of the annual budget submission of the President to Con-*  
3 *gress under section 1105(a) of title 31, United States Code,*  
4 *shall submit information regarding each Federal depart-*  
5 *ment and agency involved in San Francisco Bay protection*  
6 *and restoration, including—*

7               “(1) *a report that displays for each Federal*  
8 *agency—*

9                       “(A) *the amounts obligated in the preceding*  
10 *fiscal year for protection and restoration*  
11 *projects, activities, and studies relating to the*  
12 *San Francisco Bay; and*

13                       “(B) *the proposed budget for protection and*  
14 *restoration projects, activities, and studies relat-*  
15 *ing to the San Francisco Bay; and*

16               “(2) *a description and assessment of the Federal*  
17 *role in the implementation of the San Francisco Bay*  
18 *Plan and the specific role of each Federal department*  
19 *and agency involved in San Francisco Bay protection*  
20 *and restoration, including specific projects, activities,*  
21 *and studies conducted or planned to achieve the iden-*  
22 *tified goals and objectives of the San Francisco Bay*  
23 *Plan.”.*
