- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 19 That the Laws of Maryland read as follows:

- 22 (a) The State Board shall encourage the county boards to incorporate
- 23 age-appropriate lessons on dating violence, DOMESTIC VIOLENCE, diabetes and its



treatment and prevention, oral disease prevention, and dental health promotion into the county boards' health education curriculum.

3 (b) On or before December 1, 2015, and every 5 years thereafter, the Department 4 shall report to the Governor and, subject to § 2–1246 of the State Government Article, to 5 the General Assembly a summary of the information reported to the State Superintendent 6 during the COMAR certification process.



- 9 (a) In this subtitle the following words have the meanings indicated.
- 10 (b) (1) "Abuse" means any of the following acts:
- (i) an act that causes serious bodily harm;
- 12 (ii) an act that places a person eligible for relief in fear of imminent 13 serious bodily harm;
- 14 (iii) assault in any degree;
- 15 (iv) rape or sexual offense under §§ 3–303 through 3–308 of the Criminal Law Article or attempted rape or sexual offense in any degree;
- 17 (v) false imprisonment; [or]
- 18 (vi) stalking under § 3–802 of the Criminal Law Article;
- 19 (VII) HARASSMENT; OR
- 20 (VIII) MALICIOUS DESTRUCTION OF PROPERTY.
- 21 (2) If the person for whom relief is sought is a child, "abuse" may also include abuse of a child, as defined in Title 5, Subtitle 7 of this article. Nothing in this subtitle shall be construed to prohibit reasonable punishment, including reasonable corporal punishment, in light of the age and condition of the child, from being performed by a parent or stepparent of the child.
- 26 (3) If the person for whom relief is sought is a vulnerable adult, "abuse" 27 may also include abuse of a vulnerable adult, as defined in Title 14, Subtitle 1 of this article.
- 28 (c) "Child care provider" means a person that provides supervision and care for a 29 minor child.

- 1 "Cohabitant" means a person who has had a sexual relationship with the (d) 2 respondent and resided with the respondent in the home for a period of at least 90 days 3 within 1 year before the filing of the petition. "Commissioner" means a District Court Commissioner appointed in 4 accordance with Article IV, § 41G of the Maryland Constitution. 5 6 (f) "Court" means the District Court or a circuit court in this State. 7 "Emergency family maintenance" means a monetary award given to or for a person eligible for relief to whom the respondent has a duty of support under this article 8 based on: 9 10 (1) the financial needs of the person eligible for relief; and the resources available to the person eligible for relief and the 11 (2) 12 respondent. "Executive Director" means the Executive Director of the Governor's Office of 13 (h) Crime Control and Prevention. 14 "Final protective order" means a protective order issued under § 4–506 of this 15 (i) subtitle. 16 17 "HARASSMENT" MEANS AN INTENTIONAL OR KNOWING COURSE OF **(J)** CONDUCT OR A SERIES OF ACTS, INCLUDING WRITTEN OR ELECTRONIC 18 19 COMMUNICATION OR TRANSMISSION, THAT CONTINUES AFTER A REASONABLE WARNING OR REQUEST TO STOP BY OR ON BEHALF OF ANOTHER PERSON AND THAT: 2021**(1)** SERIOUSLY ALARMS, TORMENTS, TERRORIZES, OR DISTURBS 22ANOTHER PERSON; 23**(2)** HAS NO LEGAL PURPOSE; AND 24**(3)** WOULD CAUSE A REASONABLE PERSON TO SUFFER MENTAL OR EMOTIONAL DISTRESS. 25 26 [(j)] **(K)** "Home" means the property in this State that: 27 is the principal residence of a person eligible for relief; and (1)
- 28 (2) is owned, rented, or leased by the person eligible for relief or respondent 29 or, in a petition alleging child abuse or abuse of a vulnerable adult, an adult living in the 30 home at the time of a proceeding under this subtitle.



- 1 the State's Attorney for the county where the child or vulnerable adult lives, or, if different, where the abuse is alleged to have taken place;
- 3 2. the department of social services that has jurisdiction in 4 the county where the child or vulnerable adult lives, or, if different, where the abuse is
- 5 alleged to have taken place;
- 6 3. a person related to the child or vulnerable adult by blood, 7 marriage, or adoption; or
- 8 4. an adult who resides in the home.
- 9 **[(p)] (R)** "Residence" includes the yard, grounds, outbuildings, and common 10 areas surrounding the residence.
- 11 **[(q)] (S)** "Respondent" means the person alleged in the petition to have 12 committed the abuse.
- 13 **[(r)] (T)** "Temporary protective order" means a protective order issued under § 14 4–505 of this subtitle.
- 15 [(s)] (U) "Victim" includes a person eligible for relief.
- 16 **[(t)] (V)** "Vulnerable adult" has the meaning provided in § 14–101(q) of this 17 article.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2017.
