A BILL

To direct the Director of the Bureau of Land Management to study the effects of drone incursions on wildfire suppression, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Aerial Incursion Re-
5 percussion Safety Act of 2019” or the “AIR Safety Act
6 of 2019”.

1 **SEC. 2. STUDY ON EFFECTS OF DRONE INCURSIONS ON**
2 **WILDFIRE SUPPRESSION.**

3 (a) **STUDY REQUIRED.**—The Director of the Bureau
4 of Land Management, in consultation with the Chief of
5 the Forest Service, shall conduct a study on the effects
6 of drone incursions on the suppression of wildfires with
7 respect to lands managed by the Department of the Inte-
8 rior or the Department of Agriculture.

9 (b) **STUDY CONTENTS.**—In conducting the study re-
10 quired under subsection (a), the Director shall—

11 (1) determine, for each of the five most recently
12 completed calendar years, the number of occurrences
13 in which a drone incursion interfered with wildfire
14 suppression and the effect of each such occurrence
15 on—

16 (A) the length of time required to achieve
17 complete suppression;

18 (B) the effectiveness of aerial firefighting
19 responses; and

20 (C) the amounts expended by the Federal
21 Government; and

22 (2) evaluate the feasibility and effectiveness of
23 various actions to prevent drone incursions, includ-
24 ing—

25 (A) the use of reasonable force to disable,
26 damage, or destroy a drone;

1 (B) the seizure of a drone, including sei-
2 zure with a net device; and

3 (C) the dissemination of education mate-
4 rials relating to the effects of drone incursions
5 on wildfire suppression.

6 (c) REPORT.—Not later than 18 months after the
7 date of the enactment of this Act, the Director shall sub-
8 mit to the Committee on Natural Resources of the House
9 of Representatives and the Committee on Energy and
10 Natural Resources of the Senate a report on the findings
11 of the study required under subsection (a) and any rec-
12 ommendations of the Director relating to such findings.

13 (d) DEFINITIONS.—In this section:

14 (1) DRONE.—The term “drone” means an un-
15 manned aircraft system owned by a private indi-
16 vidual or entity.

17 (2) DRONE INCURSION.—The term “drone in-
18 cursion” means the operation of a drone within any
19 airspace for which the Administrator of the Federal
20 Aviation Administration has issued a temporary
21 flight restriction because of a wildfire.

22 (3) WILDFIRE SUPPRESSION.—The term “wild-
23 fire suppression” has the meaning given such term
24 in section 46320(d) of title 49, United States Code.
